I/We agree to pay such sum as may be necessary to cover the replacement or repair of the equipment at regular prices established by Apex Music Co., Inc / or its assignee for all damaged, broken, or missing parts immediately upon presentation of billing and further agree that any sums deducted from my/our security deposit for that billing will be promptly reimbursed by the renter, to restore the original security deposit.
